Do not use **CIVITAS HARMONIZER™** for applications on ornamentals. **NOT FOR AQUATIC USE.** Shake or agitate **CIVITAS HARMONIZER™** immediately prior to use. Use 1 part of **CIVITAS HARMONIZER™** with 8 parts of **CIVITAS™** by volume. For purposes of color adjustment the ratio of Petro-Canada **CIVITAS HARMONIZER™** to **CIVITAS™** can be varied from 1 to 8 up to 1 to 16 by volume and any value in between. Read the **CIVITAS™** label carefully and follow all use directions.
